### **Job Duties and Responsibilities:**

The employee must be able to demonstrate, supervise, discuss, assist and mentor student interns in assessment and diagnosis, patient management, health promotion and disease prevention, communication and record keeping, professional ethics and jurisprudence, information and technology literacy and intellectual and professional development.
- Evaluate student interns consistently and fairly. Set up files on each intern to facilitate evaluation and grading. Maintain accurate records on each intern that shall include attendance and evaluations of the clinical competencies and submits procedure credits and assessments in a timely manner.
- Is available to cover emergencies after hours and on weekends.

- Committed to quality patient care and student mentoring and learning.
- Must have strong interpersonal and communication skills, be able to work with supervisors, peers and students in a professional manner and demonstrate ethical and dependable behavior.
