SUMMARY: Support Logan's efforts to accomplish their mission in graduating competent, qualified, confident doctors of chiropractic. Responsibilities include delivery of consistently high quality patient care using evidence-informed, patient-centered approaches while training and mentoring Logan senior interns. A superior level of communicative ability is expected.

PRINCIPLE DUTIES AND RESPONSIBILITIES:

1. Responsible for patient care delivered within one or more of Logan University's Integrative Health Centers, including patient consultation and evaluation, rendering of diagnosis(es) and application of appropriate treatment strategies, including referral. Adherence to evidence-informed, patient-centered principles and guidelines is expected. Thorough and timely clinical documentation is required.
2. Demonstrates, assists and supervises Logan interns in the delivery of patient care including all aspects of patient communication, history taking and examination processes, and treatment and/or referral. Consistently provide formal and informal objective assessment of intern knowledge, skills and attitudes; adherence to the RIME format of assessment is required.
3. Responsible for managing day to day operations of the Logan Integrated Health Center, including patient and intern scheduling, data collection for QA program

budgeting, and other administrative purposes, and development and maintenance of interprofessional relationships within the integrated system they are assigned.

4. Responsible for consistent efforts directed toward professional development, scholarship and/or clinical research.
5. Employee will follow all quality patient care measures and initiatives deployed.

COMPETENCIES: Must be able to write clearly and informatively. Must have leadership and decision-making abilities and know how to delegate work assignments. Must be ethical, dependable and willing/able to follow organizational policies and procedures. Must be able to prioritize, manage competing demands. Must deal with a wide variety of people in a professional manner. To perform the job successfully, an individual should have interpersonal skills that allow him/her to focus on resolving conflict, keeps emotions under control and remain open to others' ideas.

QUALIFICATIONS: To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

Doctor of Chiropractic degree and minimum of seven years practice experience, or equivalent combination of relevant education and clinical experience. Postgraduate degrees and/or diplomat status is preferred; significant experience within an integrative setting as a provider is strongly preferred.

Ability to demonstrate all skills related to the successful practice of chiropractic.

Must have basic math skills and ability to read, analyze, and interpret general business periodicals, professional journals, technical procedures, and/or governmental regulations. Ability to write reports, business correspondence, and procedure manuals. Ability to effectively present information and respond to questions from groups of managers, clients, customers, and the general public. Ability to solve practical problems and deal with a variety of concrete variables in situations where only limited standardization exists. Ability to interpret a variety of instructions furnished in written, oral, diagram, or schedule form.

Certificates, Licenses, Registrations: Must be a Chiropractor licensed in the State of Missouri.

Other Qualifications: Must be able to handle periods of weekly work in excess of 40 hours.
