The overall governance and management of all IPC Sports (including World Para Powerlifting) is subject to the detailed provisions of Chapter 2.7 of the IPC Handbook.

# PROGRAM FOR DEVELOPING AND CREDENTIALING OFFICIALS

## **USAPP MANDATORY REFEREE CLINICS -- WHO MAY TEACH CLINICS?**

Any current IPC Recognized Cat. I or Cat. II Referee in good standing with the IPC and USAPP, can teach the clinics after attending one clinic at each level and being recognized as a trainer by the USA Para Powerlifting High Performance Referees Committee. This designation is accompanied by appointment to the High Performance Referees Committee.

At these clinics, the candidates will learn the methodology of uniform application of specific rules and protocols defined in the IPC Handbook The USA Para Powerlifting rules handbook is the IPC Handbook. The Clinics are designed to take any person, with or without prior experience, who's interested in becoming a USA Para Powerlifting referee, through the local level on the pathway to becoming a National IPC Referee It is virtually impossible to become wholly proficient in understanding and applying the rules and regulations of performance and administration with only a few hours of training. Therefore, we have adopted a multi-level specificity of training program. It includes didactic, hands on, and real-time training. To be certified at any specific officiating level, it will be necessary to

attend the corresponding certification clinic and demonstrate proficiency by passing both a written and practical test.

Please note: that these clinics may be changed at any time as circumstances dictate.

#### REFEREE ELIGIBILTY

Serving as a USAPP Technical Official (TO), is dependent upon not being barred from participation by the USA PPAZJT, the IPC/ World Para Powerlifting, or any of their bodies, or a judiciary decree.

# **USAPP REFEREE PATHWAY**

All USAPP Referees will have an official "License Book" in which to log their participation.

Local USAPP Referee – No prior experience necessary. Complete Level 1 Referees' Clinic

Credentialed Local Referees may participate as a Chair Referee at any Local Event.

USAPP Regional Referee – Has worked a minimum of 2 events with an IPC Referee.

Recommended for ascension submitted by the HPRC to the USAPP Complete Level II Referees' Clinic

Regional Referees may participate at any local event in any position.

USAPP- National Referee – Worked a minimum of 4 events with an IPC Referee. At least two of the events must be USAPP Sanctioned Events.

Complete Level II Referees' Clinic

Recommended for ascension submitted by the HPRC to the USAPP Any level USAPP Referee may participate in an HPRC designated position at USA Para Powerlifting Events.

# **COMPENSATION AND EXPENSES**

Candidates and Certified USAPP Referees are responsible for any and all expenses for travel, food and accommodations to/from and during all clinics. Neither USAPP, IPC nor World Para Powerlifting will be responsible for any costs associated with

candidates' participation at any clinic. This does not exclude any voluntary third party reimbursement. USAPP is a tax exempt 501-3c organization.

There is an IPC established pathway to attain IPC Referee certification. The process is exclusively within the purview of the IPC/World Para Powerlifting organization. The NGB has the authority to submit candidates provided to them by the USA HPRC.
