As the current competition cycle will end after the Tokyo Paralympic Games and new Technical and Classifications Rules and Regulations will be implemented in October 2021, all Classifiers must renew their licenses and levels by participating in a Recertification Course for 2021 to 2025.

All Classifiers regardless of their level or recent activity are required to participate and pass the examinations in the course or else their license will become inactive.

<b>Examination</b>	<p>All Classifiers wishing to renew and confirm their level for the 2021 to 2025 cycle must pass the examinations.</p> <p>The examinations will consist of theoretical, practical and English language components.</p> <p>Results will not be communicated immediately at the end of the course but in due time after correction.</p>
<b>Programme (Provisional)</b> <i>Subject to change</i>	<p>Course: 27 September to 06 October 2021</p> <p>Examination Period: 06 to 10 October 2021</p> <p>Recordings will be made available immediately following the sessions for participants unable to attend live. The examinations will be available to be completed over the period at a convenient time to the participant with time limits on each examination.</p>
<b>Technology Requirements</b>	Participants require access to a computer or smartphone with a minimum internet connection speed of 0.5 Mbps for the duration of the course.
<b>Cost</b>	<p>The cost to attend the course and the license for 2021 to 2025 is 75 EUR.</p> <p>WPPO and the IPC will issue an invoice that must be paid ahead of the course.
