Reaffirmation Process

We are preparing for our comprehensive evaluation with the HLC. This review leads to an action regarding the reaffirmation of Logan's accreditation. Logan's last reaffirmation occurred in 2011.

Comprehensive evaluations occur at different points along each pathway as set by the HLC. Logan is on the open pathway.

For the open pathway, the HLC requires:

- A comprehensive evaluation in year 10
- An assurance review in year 4
- A quality initiative in years 5-9

Evaluations are conducted by teams of peer reviewers. The evaluation occurs in the final year of each pathway cycle and includes an action regarding the reaffirmation of accreditation.



Criterion 4: Teaching and Learning Evaluation and Improvement

The institution demonstrates responsibility for the quality of its educational programs, learning environments and support services. It evaluates their effectiveness for student learning through processes designed to promote continuous improvement.

- The institution ensures the quality of its educational offerings.
- The institution engages in ongoing assessment of student learning as part of its commitment to the educational outcomes of its students.
- The institution pursues educational improvement through goals and strategies that improve retention, persistence and completion rates in its degree and certificate programs.
